## 4. Superintendent Report - Adam Trumbly

**Superintendent Trumbly** states the superintendent report is as follows: Total oil produced 309,312.51, royalties paid \$3,321,300.81, total gas produced 162,526 MCF, royalties paid \$59,865.47, total gas liquids 257,038 gallons, royalties paid \$33,666.41, total tank bottom 0, royalties paid \$0, water usage royalty paid \$750.00, waste disposal royalty paid \$12,862.25. Rentals/Bonus — Oil and Gas Rentals Paid \$5,094.00, Oil and Gas Bonus Paid \$0, Rental \$0, Saltwater Easement Rental \$2,700.00, and Late Payment Charges \$0. Aggregates - APAC produced 34,413.84 tons and paid \$40,195.37 in royalty (December). Candy Creek Crusher produced 3,107.26 tons and paid \$3,728.71 in royalty (November) and produced 1,065.77 tons and paid \$1,376.97 in royalty (December). Burbank Materials produced 12,968.13 tons and paid \$16,469.52 in royalty (November) and produced 17,210.65 tons and paid \$21,857.53 in royalty (December). Rocky Banks produced 162 cubic yards and paid \$50.00 in royalty (November and December). Wilson Ranch produced 0 tons and paid \$0 in royalty. Schmidt Brothers produced 200 cubic yards and paid \$150.00 in royalty (December). Producing wells - 14,852 (18,082 less 3,230 SWD wells) —Oil 13,319 wells, Gas 1,144 wells, Oil & Gas 62 wells, CBM 327

wells, SWD/WI 3,230 wells. Permits issued – 1 workover, 9 plugging, 1 emergency plugging, 2 emergency workover, 0 emergency drilling, and 8 drilling. There are 0 new drilling completions to report. **Superintendent Trumbly** gives the Council a terminated leases list for 2020-2023. **Second Chair Red Eagle** asked for quarterly updates on the terminated leases. **Councilman Revard** and **Councilman Redcorn** inquire about well records and their availability. **Superintendent Trumbly** states that they are still working on it. **Councilman Revard** reiterates about why the well record information is so valuable. **Councilman Revard** inquires about the status on the roll out of the CFS and is told that it is still March or April. He then asks about the unfilled staff positions. **Superintendent Trumbly** states that there is there is one position in Lease Management that is being filled.

#### 5. BTFA Update – Stephanie Davis

**Ms. Davis** states that the March payment is \$4,835 per full headright. It will be in accounts on March 1<sup>st</sup> and should be direct deposited into accounts or mailed on the 4<sup>th</sup> or 5<sup>th</sup>. The BTFA office can be contacted at 918.287.5791.

#### 7. New Business

#### a. NuCera - Kevin Chesnut

Mr. Chesnut states that NuCera, formerly Baker Hughes, would like to drill new injection disposal well approximately 500 feet south of the present one. Councilman Revard asked in the injection zone will be the same as the original and is told yes. Statements were made regarding the change in regulation for this type of well and Chairman Waller states that the same process previously used in Osage County should continue to be used. Councilman Revard asks why the existing well needs to be replaced. David Zook, geologist consultant, states that there is a bridging problem and that the casing has deteriorated. Councilman Redcorn asks how many employees are working there and is told around 100. Rollie Wilson asks about the time frame for submitting the request and is told approximately two months.

#### b. SCS engineers/AEL - Class 1 Well - Kenneth Burkett

Mr. Burkett seeks approval for American Environment Landfill (AEL) to develop a UIC Class 1 non-hazardous injection well near their landfill in Sand Springs. They are proposing a royalty of \$0.40 per barrel with an annual minimum royalty of \$80,000. The entire proposal was supplied to the Council members. Councilman Revard asks how they monitor the incoming waste to determine that it is non-hazardous. Mr. Burkett states that they will continue with their current procedures to make sure that it is nonhazardous.

### c. Stewart Stone Inc. - Quarry reopening - Larry Stewart

Mr. Stewart would like to open quarry in Osage County and obtain a mining permit from the Council. He supplied the Council members with a proposal for his plans.
